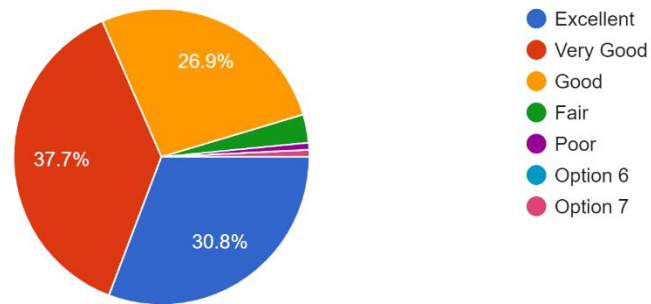

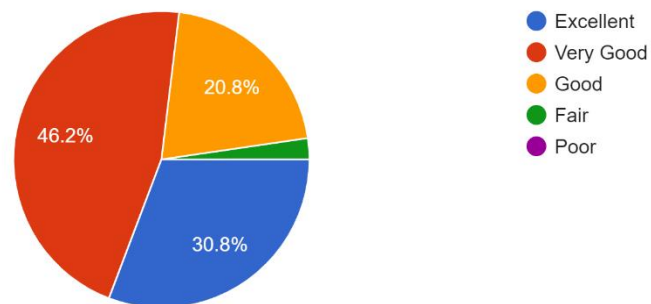

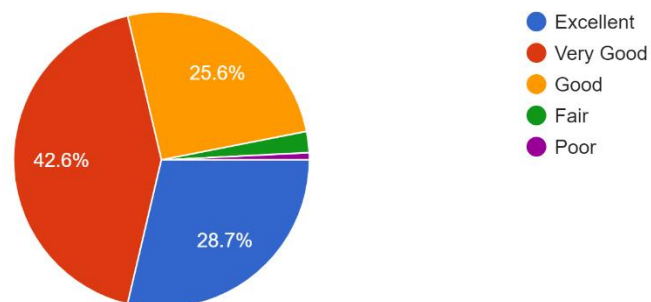
2. Extent of syllabi covered in the Class

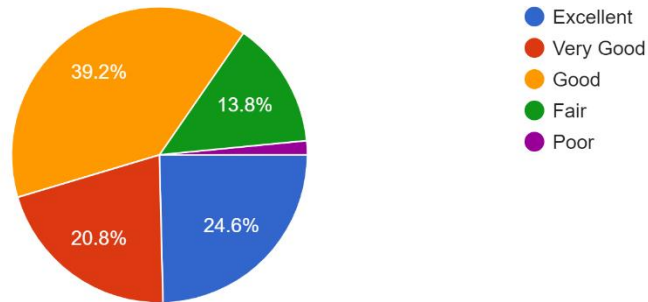


3. Course delivery by faculty members in the class

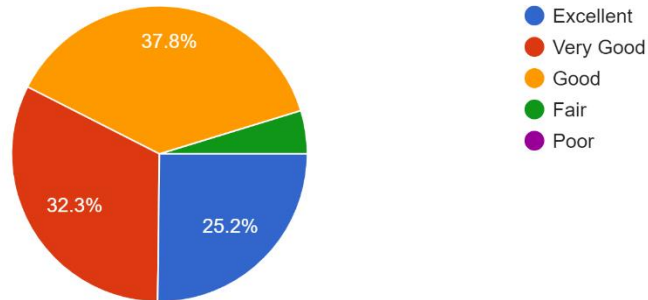

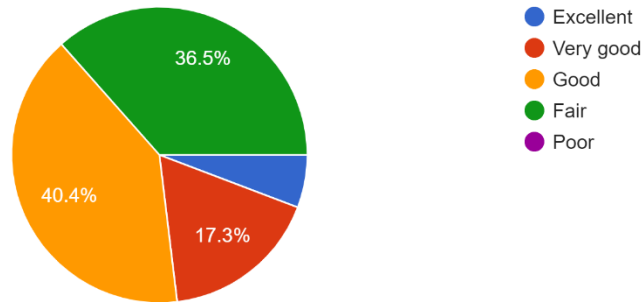
ALUMNIS FEEDBACK 2021-2022 (Responses) SPREADSHEET REPORT :
